PROFESSIONAL HIGHLIGHTS

As a certified baseball agent and sports attorney, Mr. Blank has handled complex negotiations and baseball arbitrations. In 2008, Mr. Blank obtained the second largest raise of any major league baseball player through the arbitration process and in 2009, he obtained a contract in excess of \$7 million through the arbitration process for his client Garrett Atkins.

Recent accomplishments include successfully trying a business litigation case with partner Norma Garcia Guillen where the Court entered a \$2.7 million judgment in favor of GRBB's client following a bench trial. Mr. Blank and Ms. Garcia Guillen also teamed up to obtain a bench trial victory in a lawsuit involving an ownership dispute concerning a duplex. Mr. Blank obtained dismissal of a lawsuit brought by six operators of medical marijuana dispensaries regarding the constitutionality of a city's total ban on such dispensaries.

Mr. Blank has worked on numerous high profile litigation cases.

- » He was Sheppard Mullin Richter & Hampton's lead associate on the high-profile dispute between the City of Anaheim and the Los Angeles Angels of Anaheim concerning the team's name change.
- » In a matter of first impression in California courts, Mr. Blank conducted extensive research and carefully drafted briefs arguing that the right to rescind contracts under the Truth In Lending Act does not apply on a class-wide basis. The trial court agreed with Mr. Blank's arguments and the trial court decision was upheld in a landmark decision by the Appellate Court, which held that the right of rescission under the Truth In Lending Act is a personal remedy not suitable for class action treatment. *Laliberte v. Pacific Mercantile Bank* (2007) 147 Cal.App.4th 1.
- » In a highly publicized eminent domain case, Mr. Blank authored the critical briefs which led to Cottonwood Christian Center successfully obtaining a preliminary injunction against the City of Cypress which was trying to take Cottonwood's land. *Cottonwood Christian Center v. City of Cypress* (C.D. Cal. 2002) 218 F.Supp.2d 1203.

COMMUNITY

- » Mr. Blank serves on the executive board and on the management board of the Constitutional Rights Foundation, Orange County ("CRF-OC"), a non-profit, non-partisan education organization dedicated to promoting civic literacy, youth leadership, and career awareness among Orange County teens. He is currently co-chair of the CRF-OC's Career Forum Committee, and a member of the CRF-OC Mock Trial committee.
- » Since 2011, Mr. Blank has taught and mentored high school students, serving as the Attorney Coach for the Trabuco Hills High School mock trial team. In December of 2016, the Trabuco Hills High School team won the Orange County mock trial championship in a competition that featured 46 teams from 37 different schools in Orange County. In January of 2024, Trabuco Hills High School won Championship Round A for its eighth consecutive victory before falling in Championship Round B and finishing as the county's runner-up.
- » In April of 2024, Mr. Blank's mock trial student Daniel Tinacci was named as the Henry Moore Orator of the Year and received a \$2,500 college scholarship from the Orange County Trial Lawyers Association.
- » Mr. Blank was recognized as the CRF-OC Mock Trial Attorney Coach of the Year on February 14, 2014.
- » Mr. Blank frequently judges and scores mock trial and moot court competitions at the high school, college, and law school levels. Most recently, Mr. Blank served as the presiding judge for four rounds of the 2024 Teach Democracy Mock Trial Championship in Los Angeles and for three rounds of the 2023 CRF California High School Mock Trial Championship in Los Angeles. In 2019, Mr. Blank served as the presiding judge in four rounds, including a semifinal round, of the 2019 CRF California High School Mock Trial Championship in Sacramento, California. Mr. Blank also served as the presiding judge in four rounds, including a semifinal round, of the 2019 Gladiator 1-on-1 Mock Trial World Championship. Previously, Mr. Blank served as the presiding judge in two rounds of the 2019 CRF California High School Mock Trial Championship in Orange County, California, four rounds of the 2016 CRF California High School Mock Trial Championship in Sacramento, California, and one round of the 2015 CRF California High School Mock Trial Championship in Riverside, California.
